The work includes re-designing of some or whole part of all Re-print / Print items for which no extra payment shall be made. Firm will be required to make modifications in the design as per requirement or on orders of the officials of the department.

Eligibility of Bidders:

1. The bidder must be a bonafide printer i.e. exclusively an organization doing such assignments or an organization having exclusively defined division within the company which handles such assignments.
2. 3 years' experience in the field of designing and printing of publicity material in Government sector is necessary. Firm will have to enclose a self-certified declaration of three years' experience along with 3 work orders of Rs. 100 Lakhs each in any three years in 2018-19, 2019-20, 2020-21 **OR** 2019-20, 2020-21, 2021-22.
3. Bidder will submit Copy of valid GST Registration Certificates and Copy of Certificate of incorporation or Service Tax / GST Registration certificate.
4. A minimum average turnover of Rs. 100 Lakhs per annum from relevant activities during the last three financial years, i.e., 2018-19, 2019-20, 2020-21 **OR** 2019-20, 2020-21, 2021-22.
5. Firm should have valid registration of Rajasthan State (shop registration) having manufacturing facility in Jaipur.
6. Firm should have its own four colour printing machines with complete set up, self-declaration to be enclosed.
7. Firm should be registered / empanelled with Government of Rajasthan
8. CA certificate **OR** audited balance sheet of explaining turnover of three years is required.
9. Firm will have to provide sample / s of the printing material in the department before opening of the technical bid.
10. Self-declaration by the bidder that the firm is not blacklisted or debarred by any Government organization.
11. If the bidder breaches any provision of code of integrity prescribed for bidders in the RTPP act and chapter VI of these rules.

TERMS & CONDITIONS

1. The minimum average turnover of the bidder should be Rs.100Lakhs per annum in last three financial years i.e., i.e., 2018-19, 2019-20, 2020-21 OR 2019-20, 2020-21, 2021-22.
2. 3 years previous experience in Govt Sector in this field is necessary. 3 work orders of Rs. 100 Lakhs each in any three years in 2018-19, 2019-20, 2020-21 OR 2019-20, 2020-21, 2021-22.
3. The bid offers shall be submitted in online separate envelopes, containing the technical and financial bids. Bid processing fee in favour of M.D. RISL and bid document fee of Rs.1000/- each and Rs. 1.60 Lakhs (2 % of the cost of work) for bid security will have to be deposited in Government budget head /s.
4. Successful bidder will have to deposit performance security equal to 2.5% of the total value of the work order within 15 days of issue of work order. No interest will be paid on these deposits. The bid security deposited earlier may be adjusted against the performance security. Performance Security will be refunded as per the rules.
5. Financial bids of bidders who qualify in technical bids shall be opened.
6. The rates quoted in the financial bid shall be inclusive of applicable taxes, showing the cost and tax components separately. .
7. **Firms will be required to quote rate for designing and Re-printing / Printing of items. Firm will be decided on the basis of L 1 bidder item wise. These rates will be valid for a period of c.f.y.**
8. Taxes would be paid as per rules.
9. Quantity of procurement may differ according to the rates received. Bidder shall not claim for stipulated quantity.
10. Scope of work includes re-designing of some or whole part of all Re-print / Print items for which no extra payment will be made. Firm will be required to make modifications in the design as per requirement or on orders of the officials of the department.
11. TDS for income tax and GST would be deducted by Department of Tourism on all the payments as per rules. The bidder is bound to provide PAN number to the Department of Tourism. The agency is entitled to seek details of such deductions made.
12. No advance payment for the ordered work will be given to the successful bidder.
13. Delivery of printed material would be made at ParayatanBhawan, Sanjay Marg, Opp. Vidhyakpuri Police Station Jaipur within one month after the approval of dummy of the print material / issue of work order by the department. For delivery of material, no additional payment shall be payable.
14. Creative production of all print material will be the property of Tourism Department which firm will have to provide in soft copy to the department.
15. Firms may be asked for an AV presentation on the work as part of technical bid.
16. Department may issue repeat orders for the work on the rates approved through the bid for any quantity during the period of contract.
17. Selected firm will have to sign & submit an agreement on non-judicial stamp paper of Rs.500/- with department. The stamp paper should have been issued in Rajasthan.

18. Payment will be made after successful supply and issuance of work quality certificates constituted for the purpose as per the work order & agreement.
19. Firm will have to submit bank details for funds transfer.
20. Department of Tourism reserves the right to reject any offer without assigning a reason.
21. Wherever Specific Terms and conditions have not been spelt out in bid document, General Finance Accounts Rules & RTPP Act. 2012 RTPP Rules 2013 of the state govt. shall apply in the current bid.
22. Canvassing in any form would result in rejection of the bidder.
23. Delay by Bidder in submission of additional information or clarifications sought by Department of Tourism may cause the bid to be liable for rejection
24. If in response to this bid, the bidder makes any claim, which does not reflect the truth or material representation of facts, the bid will be liable for rejection.
25. As per the Rule 73 (2) of RTPP Act 2012 & RTPP RULES 2013, Repeat order up to the cost of original Contract may be placed after the successful completion of work.
26. PERFORMANCE SECURITY:
- Performance Security @ 2.5% of the total value of the work order will have to be deposited by the successful bidder within the time period stipulated by Department of Tourism.
 - Department of Tourism on its part would ensure that after the satisfactory completion of the contract, the performance security money is returned as per the rules.
27. The approved bidder shall be deemed to have carefully examined the conditions, specifications, etc. If he has any doubts as to the meaning of any portion of the conditions or of the specification, etc., he shall before the signing the contract, refer the same to the officer and get clarifications.
28. REFUND OF BID SECURITY: The bid security of unsuccessful bidder shall be refunded soon after the final acceptance of bid of successful bidder and issue of work order/signing of contract
29. FORFEITURE OF BID SECURITY: The bid security will be forfeited in the following cases:
- When the bidder withdraws or modifies its bid after opening of bids.
 - When the bidder does not execute the agreement, if any, after placement of supply / work order within the stipulated period.
 - When the bidders fail to commence the supply of the goods or services or execute work as per work order within the time specified.
 - When the bidders do not deposit the performance security within the time specified after the work order is placed.
 - If the bidder breaches any provision of code of integrity prescribed for bidders in the RTPP act and chapter VI of these rules.
30. Forfeiture of Performance Security - The amount of performance security may be forfeited in the following cases :-
- a) Upon concurrence of bidder default or fails to make complete supply satisfactorily within the time specified. The procuring entity shall without prejudice to its other rights and remedies, hereunder or in law, be entitled to encash from the performance security as damages for such bidder default: or
 - b) If the bidder breaches any provision of the code of integrity prescribed for bidders under section 11 of RTPP act and chapter VI of RTPP rules and this bidding document. The bidder would be liable for forfeiture of the performance security.
 - c) If in the judgement of the procuring entity, the bidder with beneficial ownership from countries sharing land border with India as per rule 13 of RTPP rules and Gov. of

Rajasthan notification no. F 2 (1) FD / G&T-SPFC/2017 dated 01.01.2021, 15.01.2021 and 30.3.2021, for participation in any public procurement in the state, who can only be allowed after prior registration with the competent authority has not complied with the requirement.

- d) The procuring entity shall give notice of reasonable time in case of forfeiture of performance security and the decision of the procuring entity shall be final.

31. **PENALTY CLAUSE:** For any delay in delivery of goods and services the provisions of RTPP, GF & AR would apply wherever applicable. Penalty will also be leviable for under performance of the contracted work

32. **VALIDITY:** Bids shall be valid for a period of 90 days from the date of opening of financial bid.

33. **INSPECTION:**

- Duly authorized representative of Department of Tourism shall at all reasonable time have access to the supplier's premise and shall have the power at all times to inspect and examine the materials and workmanship of the goods/equipment/machinery. Successful bidder will also submit 10 nos. of finished samples before starting of production as per work order. After satisfaction on the same, successful bidder will be given go ahead as per work order.
- The bidder shall furnish complete address of the premises of his office/workshop/studio where inspection can be made.

34. **REPRESENTATION & WARRANTIES:**

The bidder hereby represents and warrants to the client that

- By entering into this agreement, it does not violate any obligations, under any other contracts entered into by it.
- No suit has been instituted against him for insolvency or bankruptcy, or for winding up proceedings.
- He is competent to enter into this agreement.
- He shall not assign or transfer his rights/obligations under this agreement.

35. **INDEMNITY:**

- The contractor shall indemnify and keep indemnified Department of Tourism against any loss or costs, charges and expenses to be incurred or suffered by the Department of Tourism by reason of or as a result of the bidder doing any act contrary to the provisions of this agreement.
- Department of Tourism shall be liable for and shall indemnify the bidder against any liability, loss, claim or proceedings arising under any statute or common law as a result of the design/production/publication of material approved of and authorised by Department of Tourism to the created by the bidder.

36. **TERMINATION OF CONTRACT:** Department of Tourism may terminate the agreement by giving three months' notice in writing. During the notice period the bidder would be bound by the contract and would discharge responsibilities in letter and spirit of the contract.

37. **JURISDICTION:** All legal proceedings, if necessity arises to institute, by any of the parties shall have to be lodged in courts situated in Jaipur, Rajasthan and not elsewhere. This agreement will be deemed to have been made in Jaipur.

38. The first appellate authority will be Principal Secretary Tourism and second authority Finance Department Government of Rajasthan under RTPP Act 2013 & rules therein.

39. **NON-EXCLUSIVE:** This agreement does not establish the Agency as the exclusive Agency of the Department of Tourism during the term of this agreement or otherwise.
40. **NOTICE:** Any notice given under the agreement signed shall be sent by letter or fax to the usual address or last known place of business and shall be deemed to have been received by the addressee in ordinary course of post, if by letter or instantly in case of fax.
41. **ENTIRE AGREEMENT:** This agreement constitutes the entire agreement with respect to the subject matter hereof, and may only be modified or amended in a written document signed by both parties. However, for issues & points not covered under this agreement, General Financial & Accounts rules (GF&AR) of Government of Rajasthan & RTPP Act & Rule apply.
42. **WAIVER:** No waiver or breach of any provision of this agreement shall constitute a waiver of any other provision, and no waiver shall be effective unless made in writing and signed by an authorized representative of the party against whom such waiver is to be enforced. In the event that any provision of this agreement shall be illegal or otherwise unenforceable, such provision shall be severed, and the balance of the agreement shall continue in full force and effect.
43. **MODIFICATION:**
- The expenses of completing and stamping this agreement shall be paid by the agency and Department of Tourism shall be furnished free of charge with the original stamped agreement.
 - Any modifications of this agreement shall be made in writing by mutual consent of the parties.

(1) Filing an appeal

If any Bidder or prospective Bidder is aggrieved that any decision, action or omission of the Procuring Entity is in contravention to the provisions of the Act or the Rules or the Guidelines issued there under, he may file an appeal to First Appellate Authority, as specified in the bidding Document within a period of ten days from the date of such decision or action, omission, as the case may be, clearly giving the specific ground or grounds on which he feels aggrieved:

Provided that after the declaration of a Bidder as successful the appeal may be filed only by a Bidder who has participated in procurement proceedings:

Provided further that in case a Procuring Entity evaluates the Technical Bids before the opening of the Financial Bids, an appeal related to the matter of Financial Bids may be filed only by a Bidder whose Technical Bid is found to be acceptable.

(2) The officer to whom an appeal is filed under para (1) shall deal with the appeal as expeditiously as possible and shall Endeavour to dispose it of within thirty days from the date of the appeal.

(3) If the officer designated under para (1) fails to dispose of the appeal filed within the period specified in para (2), or if the bidder or prospective Bidder or the Procuring Entity is aggrieved by the order passed by the First Appellate Authority, the bidder or prospective Bidder or the Procuring Entity, as the case may be, may file a second appeal to Second Appellate Authority specified in the bidding Document in this behalf within fifteen days from the expiry of the period specified in para (2) or of the date of receipt of the order passed by the First Appellate Authority, as the case may be.

(4) Appeal not to lie in certain cases

No appeal shall lie against any decision of the Procuring Entity relating to the following matters, namely: -

- (a) determination of need of procurement;
- (b) provisions limiting participation of Bidders in the bid process;
- (c) the decision of whether or not to enter into negotiations;
- (d) cancellation of a procurement process;
- (e) Applicability of the provisions of confidentiality.

(5) Form of Appeal

(6) Fee for filing appeal

(a) Fee for first appeal shall be rupees two thousand five hundred and for second appeal shall be rupees ten thousand, which shall be non-refundable.

(b) The fee shall be paid in the form of bank demand draft or banker's cheque of a Scheduled Bank in India payable in the name of Appellate Authority concerned.

(7) Procedure for disposal of appeal

(a) The First Appellate Authority or Second Appellate Authority, as the case may be, upon filing of appeal, shall issue notice accompanied by copy of appeal, affidavit and documents, if any, to the respondents and fix date of hearing.

(b) On the date fixed for hearing, the First Appellate Authority or Second Appellate Authority, as the case may be, shall, -

- (i) hear all the parties to appeal present before him; and

- (ii) Peruse or inspect documents, relevant records or copies thereof relating to the matter.
- (c) After hearing the parties, perusal or inspection of documents and relevant records or copies thereof relating to the matter, the Appellate Authority concerned shall pass an order in writing and provide the copy of order to the parties to appeal free of cost.
- (d) The order passed under sub-clause (c) above shall also be placed on the State Public Procurement Portal

Additional Conditions of Contract**1. Correction of arithmetical errors**

Provided that a Financial Bid is substantially responsive, the procuring Entity will correct arithmetical errors during evaluation of Financial Bids on the following basis:

- i. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of the Procuring Entity there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected;
- ii. If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
- iii. If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (i) and (ii) above.

If the bidder that submitted the lowest evaluated Bid does not accept the correction of errors, its Bid shall be disqualified and its Bid Security shall be forfeited or its Bid Securing Declaration shall be executed.

2. Procuring Entity's Right to Vary Quantities

- (i) At the time of award of contract, the quantity of Goods, works or services originally specified in the bidding Document may be increased or decreased by a specified percentage, but such increase or decrease shall not exceed twenty percent, of the quantity specified in the bidding Document. It shall be without any change in the unit prices or other terms and conditions of the bid and the conditions of contract.
- (ii) If the Procuring Entity does not procure any subject matter of procurement or procures less than the quantity specified in the bidding Document due to change in circumstances, the bidder shall not be entitled for any claim or compensation except otherwise provided in the Conditions of Contract.
- (iii) In case of procurement of Goods or services, additional quantity may be procured by placing a repeat order on the rates and conditions of the original order. However, the additional quantity shall not be more than 50% of the value of Goods of the original contract and shall be within one month from the date of expiry of last supply. If the Supplier fails to do so, the Procuring Entity shall be free to arrange for the balance supply by limited Bidding or otherwise and the extra cost incurred shall be recovered from the Supplier.

3. Dividing quantities among more than one Bidder at the time of award (In case of procurement of Goods)

- (i) As a general rule all the quantities of the subject matter of procurement shall be procured from the bidder, whose Bid is accepted. However, when it is considered that the quantity of the subject matter of procurement to be procured is very large and it may not be in the capacity of the bidder, whose Bid is accepted, to deliver the entire quantity or when it is considered that the subject matter of procurement to be procured is of critical and vital nature, in such cases, the quantity may be divided between the bidder, whose Bid is accepted and the second lowest Bidder or even more Bidders in that order, in a fair, transparent and equitable manner at the rates of the bidder, whose Bid is accepted.
