- 2.3 In case this turnover is not reflected separately in the balance sheet or P&L account, a statement duly certified by CA in respect of the event related turnover of the organization must be enclosed.
- 2.4 Estimated cost of the work shown as Rs. 500 lakhs are to be spent on multiple events and expected to be done by multiple agencies as per procurement procedure.
- 2.5 The organization must have been in existence for at least 5 (five)years (as on last date of submission of proposal).

#### **1. Correction of arithmetical errors**

- iii. If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (i) and (ii) above.
